

## **North West Air Ambulance Terms & Conditions**

There are just a few last things for you to think about and agree to before you book your place and start your fundraising journey with us.

1. You need to raise a minimum of **£250** in sponsorship.
2. Gift Aid either on a sponsor form or online giving site, such as [www.JustGiving.com](http://www.JustGiving.com), does not count towards your minimum sponsorship amount.
3. You must pay at least **80%** (£200) of the minimum sponsorship amount **3 weeks** before the date of the event, either via an online giving site, over the phone, via our website or by a cheque made payable to 'North West Air Ambulance'.
4. You will forward all remaining proceeds from this event within 12 weeks after the event date.
5. Your place must not be used to raise money for any other charity.
6. You need to inform us of any other fundraising activity that you carry out apart from collecting sponsorship.
7. You must not offer your place to any other person if, for whatever reason, you are unable to participate, please notify us immediately if this is the case
8. You must read and agree to all the terms and conditions put in place by Blackpool Pleasure Beach

### **Blackpool Pleasure Beach – activity participation agreement**
